

# State-by-State Unified Certification Program (UCP) Tracker

U.S. Department of Transportation's New Rule Regarding the Disadvantaged Business Enterprise (DBE) and Airport Concessions DBE (ACDBE) Programs

The regulatory landscape governing DBE and ACDBE programs is undergoing a significant transformation following the U.S. Department of Transportation's New Rule. As state and local UCPs begin implementing these changes, the rule is triggering nationwide recertification of previously certified firms and temporarily limiting the use of DBE and ACDBE participation goals in federally funded projects. The following state-by-state tracker provides an overview of the current status of the programs in each state, and when updated policies or information may be expected.
